Subject: Discount Travel Passes

Under Governor Deukmejian's Executive Order D-73-88, the Department of Personnel Administration (DPA) is responsible for implementing several measures aimed at encouraging State employee use of public transit and vanpools in areas served by congested commute routes. One of the measures provides for a subsidy of 50% (to a maximum of \$15) towards the purchase of monthly transit passes/tickets in the congested commute areas identified in the recent Caltrans Transportation Management Guidelines.

As outlined below, this program should be implemented by March 1, 1989 in all facilities served by congested commute routes. (Departments that cannot meet this date because of their large number of field locations may set an alternative date, not later than April 1, 1989, for program implementation.) In these areas the program will cover all bargaining unit employees except those in units 1 and 9, where bargaining agreements have not been reached. It will also cover all nonrepresented employees in these areas, under the authority provided by the new DPA rule 599.936 (copy attached).

This program is a pilot and will be evaluated after approximately one year to determine if it has helped to increase the number of employees commuting on public transit systems. The results of this review will determine if, and in what form the program will be continued.

While there are various ways to provide this benefit, it appears that the only way to clearly avoid making it taxable for the employee is to have the State, itself, sell transit passes/tickets to employees at a discount. For example, the State would sell a \$40 pass for \$25, making up the \$15 difference out of its own funds. State agency costs for this are to be covered within existing budgets. Discounted tickets/tokens should also be made available to employees who do not commute on a full-time basis. The discounts should be proportional to the monthly discounts. For example, daily, one-way tickets selling for 70¢ or more should be sold at a 35¢ discount. Employees purchasing 42 of these tickets would receive almost the full \$15 monthly discount. (Employees who purchase more than 42 tickets would pay the regular fare on the additional tickets purchased.) If the price of the ticket is less than 70¢, the ticket should be sold at half of full value.

Because of the tax concerns cited above, the discounts are available only when passes/tickets are purchased <u>directly</u> from the State. The State will <u>not</u> provide rebates or reimbursements on passes/tickets purchased elsewhere.

It is our understanding that several departments already sell passes/tickets to their employees. These departments should continue these sales, and initiate the 50%/\$15 discount for employees in facilities in designated urbanized areas, effective immediately. Departments not currently selling transit passes or tickets should initiate a discount sales program for transit passes and tickets in congested commute facilities by the specified target date. Each department has the flexibility to design a pass/ticket distribution system that is feasible in view of its size, distribution of employees, etc. However, each department should have sufficient sales locations to make the program reasonably convenient for affected employees. Departments may want to establish <u>specific dates and times</u> (e.g., 1st and 15th of each month) when employees can purchase their monthly passes or daily tickets.

To help departments with this effort, Caltrans and DPA have identified and contacted the major transit districts that provide transit service within the designated urbanized areas. A survey of these transit districts was conducted to determine if they sell transit passes or a monthly basis and whether or not their programs could accommodate the State's need for the purchase of such passes. The attached listing briefly highlights the pasc programs provided by the various transit districts and also includes a contact person for each district. For more detailed information on how to purchase transit passes or tickets, contact the appropriate representative identified on the attached listing.

In addition, several departments have expressed interest in the possibility of a more centralized ticket purchase/distribution process. The Commute Management Office in the Department of General Services has agreed to assess the possible operation and practicality of such systems. DPA is working with the Department of General Services to evaluate the possibility of selling transit passes at centralized locations at various state facilities. Further information regarding this process will be forthcoming.

To provide adequate program control and evaluation data, departments should have employees complete and sign the attached form when they begin to participate in the program. Employees will also be required to sign the sales record portion of the form each time they make a purchase. The form will help ensure that the employees are purchasing passes/tickets for their personal use only. It will also provide initial and on-going data that will be used in DPA's post evaluation of this pilot program. <u>Departments should maintain centralized file(s)</u> of all employees who participate in this pilot program and plan to make them available for DPA review in the Spring of 1990. 

SAMPLE NOTICE TRANSIT DISCOUNT PROGRAM

Governor Deukmejian's Executive Order D-73-88 calls for several measures aimed at encouraging State employee use of public transit and vanpools in areas served by congested commute routes. One of the measures involves 50% discounts (to a maximum of \$15) on the purchase of monthly transit passes/tickets in these areas. Following are the key points of the program:

- It covers State employees* who work in facilities served by congested commute routes including this facility, ______(address)_____.
- Monthly passes/tickets will be sold, as follows:

- Passes/tickets purchased under this program are for the employee's personal use only.
- Discount transit tickets/passes are available <u>only</u> from your employer. Employees who purchase tickets from transit districts or other outlets at full price <u>will not</u> be entitled to a State discount or rebate on the purchase of such tickets/passes.

*Employees in Bargaining Units 1 and 9 are <u>not</u> currently covered, since agreements have not been reached with these units.

599.936. Transit and vanpool incentives - nonrepresented employees.

<u>Nonrepresented employees as defined in Section 599.619 who work in facilities</u> <u>served by congested commute routes shall receive the following incentives for</u> <u>commuting to and from work on public transit or in vanpools:</u>

(a) Nonrepresented employees working in facilities served by congested commute routes as identified by the State shall be eligible for a 50% discount on monthly public transit passes sold by State agencies up to a maximum of \$15 per month. This shall not be considered compensation for purposes of retirement contributions.

(b) The State shall establish a pilot program in three facilities served by congested commute routes selected by the Department of Personnel Administration to provide up to 30 minutes per day of compensated travel time for those nonrepresented employees using public transit or State vanpools to commute to work.

(c) The State shall provide \$50 per month to each nonrepresented employee who is the primary driver of a vanpool and works in a facility served by one or more congested commute routes as identified by the State. This shall not be considered compensation for purposes of retirement contributions. The following criteria shall apply to this program:

(d) For the purpose of this rule, a vanpool is a group of seven to fifteen people who commute together in a vehicle (State or non-State) designed to carry that number of passengers. The passengers may be either State or non-State employees, provided that they work at a location served by a congested commute route.

(e) Congested commute routes are those routes identified as such in the Caltrans State Traffic Management Guidelines.
